#### INFORMATION, ACADEMIC NORMS AND RULES OF CONDUCT

- Viswa Bharathi University has been established in accordance with the Act No. 2 of 2002 of Chhattisgarh Legislative Assembly as State University notified vide No. F-73-57/2003/HE/38 dt. 26-5-2003 and published in the state gazette.
- 2. 75% attendance in Personnel Contract Program (i.e. contact classes) is compulsory. The student who attends less than 75% of classes will not be permitted to appear for the examination.
- 3. Every student should abide by and respect the declaration which he/she signs at the time of Admission.
- 4. Fee (paid in full or part) will not be refunded, whether a student attends contract program organised by the university or the Authorised centre or not, and the fee once paid will not be refunded under any circumstances.
- 5. Every student shall invariably carry the University/Authorised centre identity card while attending contact classes and produce it on demand.
- 6. There shall be no students union activity in the University/Authorised centre. Any student found involving in any union activity will be expelled from the University/Authorised centre.
- 7. No notice or any information shall be displayed by students on the notice board on the University/ Authorised centre premises. Students should refrain from writing on the walls of the University/Authorised centre or scribbling on any notice displayed on the Notice Board. They should co-operate in keeping the Authorised centre neat and clean.
- 8. Students who wilfully or otherwise damage University/Authorised centre property will be severely dealt with.
- 9. Smoking on the University / Authorised centre premises is strictly prohibited.
- Students are not allowed to organise any meeting in the University/Authorised centre or to collect money on behalf of the university/Authorised centre.
